The 2021-22 School Year for Carlstadt Public School was set to begin on Thursday, September 2nd. Classrooms were stocked, and our teachers' lessons were prepared. So imagine our shock and disappointment when a Category 4 Hurricane came crashing down upon us. CPS is not situated near any bodies of water, yet the torrential rains and flash flooding we experienced were unprecedented in our area. I received a call at 10:00 PM on September 1st from one of my evening custodians letting me know that we were taking on significant amounts of water in the lower level of the building. This began our struggle to respond as quickly as possible to an event that did not yield.

By 11:00 PM I was on the phone with Christine Messina, Vice President at AllRisk Property Damage Experts. I hope that this letter finds you well and having enjoyed the summer. The purpose of this letter is to provide my recommendation for the continued inclusion of AllRisk Property Damage Experts for disaster recovery services within the ESCNJ Cooperative Purchasing System.

Over the course of my career, which spans three school districts and 20+ years, we have had the opportunity to utilize the services provided by AllRisk for disaster recovery and training of our facilities staff.

Having been a school business administrator for a decade and now superintendent of schools I have found there are only a handful of vendors I can rely on. AllRisk Educates Public Entity Audiences about the FEMA Reimbursement Process

The first iteration of AllRisk's program **"The Two Faces of Disaster: Preparing Your Institution's Physical and Financial Recovery."** was co-created with Mark Showers, AVP of Facilities of Rowan University, following Mother Nature's one-two punch: a FEMA declared catastrophic flood on 8/14/11 and Hurricane Irene just two weeks later on 8/28/11. When Mark and his colleagues discovered the "flood of paperwork" that followed the physical disasters, AllRisk's demonstration of meticulous documentation and "FEMA ready docs" (i.e. equipment and manpower counts by shift, building and room) successfully supported the financial reimbursement process for both the 8/14/11 flood and 8/28/11 Hurricane Irene. With an emphasis on preventive and preparedness best practices, AllRisk continues to be tapped as an educational resource and speaker. "The Two Faces of Disaster" and its message of assigning a records manager, and communicating the level of detail required for FEMA-ready docs internally and externally, has been delivered to hundreds of public entity administrators. Audiences have included State higher ed institutions

(encompassing New Jersey and eight other states in October 2012), public entity members of the MRESC / ESCNJ Cooperative (2013; 2015, approved by the DCA for CEU credits), joint insurance fund meetings, various county associations, and industry professional development associations.

Experience and knowledge of regulations of the DCA:

As a licensed general contractor in the State of NJ, AllRisk has 30 years' experience in conducting initial inspections, demo activity, emergency mitigation services, and reconstruction projects in accordance with the DCA's administrative and technical guidelines, as put forth by the Division of Codes and Standards, the Division of Fire Safety and Division of Community Housing and Community Resources. AllRisk has consistently demonstrated a working knowledge of construction related law, rules and regulation as mandated by New Jersey Administrative Code (N.J.A.C.) and the Uniform Building Code (aka Uniform Construction Code or UCC) by way of our 10,000+ projects, a large percentage of which required permitting, coordination of licensed trades (electrical, plumbing, mechanical), licensed engineers, sealed plans and drawings, and multi-phase inspections and approval by Township Code Officials. AllRisk emergency operations and construction personnel are keenly aware of the importance of keeping the Division of Codes and Standards building and electrical code top-of-mind, and immediately integrate this information into AllRisk's safety and response workplans. Following a disaster, any number of a buildings systems can become comprised and unsafe. Hazards include the potential for foundations shifting and threat of collapse, drinking water can become contaminated, or the structure may simply be unsafe to re-enter. For example, it is well known by the entire workforce that if it is suspected that water has compromised or affected a structure's electrical panel, wiring and or outlets, a licensed electrician needs to be engaged to inspect, evaluate damage and rectify prior to energizing the building. AllRisk is able to expedite this step by vetting and maintaining relationships with licensed electricians who will respond on an emergency basis 24/7, just as we do. In the event that it is not safe to run extraction, dehumidification and drying equipment from the building's system, time and productivity are not lost as AllRisk has the resources, capacity and expertise to safely run our equipment on generator power.

AllRisk & the DCA: Staying Up-to-Date with Adoptions and Code Upgrades:

AllRisk maintains the responsibility of staying abreast of newly adopted or revised codes by sourcing our information from the DCA's website, by being an active member of the disaster recovery and construction industry, and by maintaining a consistent dialogue with the code official and subcontractor community. **For example**, following the high volume of water losses caused by Superstorm Sandy, so too followed a high volume of questions surrounding electrical systems, and the guidelines and grace period for replacement. AllRisk conducted all initial walk-throughs and inspections, and coordinated our array of licensed electricians and workplans in accordance with the DCA's post-Sandy alert referencing submerged panels, wiring underwater, and receptacle, outlets, etc. under water. These clarifications were *essential* to defining where AllRisk could safely and lawfully keep projects moving forward, and allow tenants and businesses to gain temporary CO's. Knowledge of gas lines, asbestos containing materials, mold and other hazardous materials is critical to ensuring that demo and debris removal are conducted to code, and with the technical expertise to follow protocol (i.e. recommending suspected materials for asbestos testing, coordinating emergency letter and abatement, etc.) *and* to prevent the potential of serious health hazards and secondary disasters.

Experience and knowledge of regulations of the OEM:

AllRisk is very familiar with the framework of the NJ's Office of Emergency Management, and is aligned with its initiatives to impart the importance of *preparedness* for every individual, family, business and community. AllRisk understands the chain of command from local, to county, to state OEM operations.

AllRisk & OEM - Staying Attuned to Local Authorities is a Part of AllRisk's Dashboard and Daily Activity

AllRisk follows OEM's guidance to leverage all forms of traditional media (TV, radio) as well as what was *once* considered new media (internet, social media and preparedness apps for Smartphones), as part of our daily mission to be informed of weather and other potential threats that may impact our client base.

Preparing to Stay Informed to OEM during a Power Outage

By creating redundancies in these platforms, and maintaining back-up power and back-up batteries for devices and emergency weather radios, AllRisk is tuned in 24/7, ready to receive any important watches, alerts, warnings, and protective actions from the OEM, local, county and state officials.

AllRisk - Supporting the Protective Actions and Plan Implementation of the OEM

When Rowan University was activated as an evacuation shelter by the OEM, AllRisk assisted in preparing the gym floor (damaged by a catastrophic flood one week prior) for 1,500 cots, as well as cleaned the gymnasium when the Red Cross evacuation shelter was demobilized.

AllRisk Experience in Working with OEM, Before Disaster Strikes

In an example that ties together the needs served by **The Division of Community Housing**, and the mission of a "ready nation", AllRisk and Camden County Director of OEM, Sam Spino co-presented **"Building a Culture of Preparedness"**, a three-hour program delivered to the leadership of 17 affordable housing communities. The program focused on no-cost and low-cost strategies to increase resiliency, based on the lessons learned from Irene and Sandy. One of the top takeaways emphasized by AllRisk, was a call-to-action for housing leaders to meet and get to know their local and county OEM coordinators, in advance of any emergency. While this program was launched at the corporate and management level during June's National Safety Month, AllRisk has taken the message one step further by focusing on the "people part of the disaster". With a message geared towards the senior population of affordable housing communities, AllRisk has provided to hundreds of residents throughout New Jersey the key information, checklists, and simple actions items for tenants to better prepare, before the next event. The 3 Step Plan, promoted by OEM, FEMA, and Ready.gov (Make a Kit, Have a Plan, Stay Informed) was customized by AllRisk for seniors to understand the importance of learning how to text (as phone lines becomes congested during an emergency), how to combat three obstacles of a power outage (obtain a 3-in-1 hand crank weather radio with flashlight and cell charger) and the importance of planning for voluntary evacuations (for both their comfort *and* to ease the burden of transportation and shelters facilitated by OEM).

Description of the Respondent's Organization, Experience and Services

AllRisk's 24/7 Emergency Response Service applies to property damage caused by, but not limited to:

- Water plumbing malfunctions, pipe breaks, ice line breaks, chiller & hot water heater malfunctions, sprinkler breaks or malfunctions, sewage backflow
- Fire
- Hurricane
- Flood
- Structural Failure Damage caused by vehicle, roof collapse,
- Mold

Emergency Services include, but are not limited to:

- 24 Hour Emergency Response
- Inspection and Assessment to determine full extent of damages
- Coordination of emergency functions for licensed trades (plumbing, electrical, HVAC and environmental testing)
- Documentation site photos, moisture mapping, drying logs, moisture meter readings and thermal imaging.
- Water Extraction
- Dehumidification
- Drying
- Water & Fire Cleanup Demo and debris removal
- Smoke & Soot Cleanup Cleaning and deodorization, contents cleaning, Ozone treatment (containment chambers set up on and off site)
- Flood Cleanup Demo & debris removal
- Sewage Cleanup
- Sanitization
- Contents Manipulation, Inventory and Storage
- Pack-Out
- Board-Up
- Temporary Shoring of Structural Failures & Repair
- Temporary Roof Tarping & Repair

** AllRisk is a Full Service General Contractor, providing the ability to seamlessly transition from Emergency Response to Restoration and Repair.

RESPONSE TIME and RESPONSE PROCEDURES - Commitment to Response Time and Accessibility. **Contract** Management – Specific Response Procedures for AllRisk's 1 hour to mobilize plus travel time.

- Initial Call Any assignment that is not received live the request for service will be returned with a call within 10
 minutes or less. All initial calls are received by AllRisk SVP of Operations Lou Crisci. AllRisk management will listen to
 the concerns and conditions of the client to determine the site conditions and reported extent of damage.
 Questions will include but are not limited to: who is the on-site contact, if the category and source of water is
 known, if class of damage is known, has water source been shut off/addressed, if affected areas are known, is the
 space occupied or unoccupied, what types of materials have been impacted (carpet, tiles, sheetrock, plaster, ceiling
 tile), is there electric available or will AllRisk supply, have any mitigation steps taken place, are there special
 instructions for access and scheduling, etc.
- 2) Supervisor Initial Arrival and Site Inspection –AllRisk Supervisor will arrive on site within ONE hour plus travel time to evaluate damage on site, taking note of any safety plan concerns and deploy equipment. AllRisk Supervisor will have a conversation with on-site contact, and take direction on any special conditions. For example, are there any hazardous materials on site; is there a survey available if asbestos is a potential concern? It is the AllRisk philosophy that while we take great pride in our depth of remediation and restoration experience, our clients are the experts in their buildings and operations and AllRisk welcomes that information accordingly. AllRisk Supervisor will photo document affected areas, conduct and record moisture readings, mark out affected areas and moisture map. Supervisor will evaluate contents, and whether to cover and protect and/or plan for manipulation of contents if necessary. AllRisk Supervisor will have a conversation with the client, taking into account this input in developing the recommended Workplan and drying methodology.
- Deployment of Crew & Equipment Supervisor will deploy appropriately sized crew (already on standby or enroute per the initial call) along with appropriate type and amount of extraction, drying equipment and cleaning materials.
- 4) Implementation of Workplan The workplan will again be discussed with designated client contact. Client will be assured that steps taken do not exceed what is necessary under the definition of Emergency Service (not permanent repairs). Supervisor will coordinate Emergency Services with technicians to dry and stabilize, keeping in mind the sequence of prioritized areas as dictated by the client. General response steps are: Barrier containment/ protection of unaffected areas, extraction of standing water, removal of wet materials, manipulation of contents, demo if applicable, Hepa vaccing if applicable, setting of drying equipment (dehumidifiers, air movers, injecti-dry systems, air filtration devices), cleaning, sanitizing and deodorizing. With an awareness of the importance of documentation, unsalvageable contents will be photo documented and handled per the client's direction.
- 5) Communication and Real Time Tracking Client contact is provided via email photo documentation, initial inspection report of impacted areas and summary of Day 1 work activity, noting the projected timeline for continuation of services (if applicable) and monitoring. Communication of status and projected timeline is as important as the technical expertise in structural drying. In scenarios with severe damage, mixed-use buildings and multiple sites, client collaboration will drive important decisions. AllRisk Supervisors are always accessible for status meetings and internal communication support. It is the Team AllRisk policy that no one from our firm responds to media requests for information, and communication is channeled only to client approved individuals.
- 6) Satisfactory Completion A walk-though with AllRisk Supervisor and client is conducted to ensure that Client Satisfaction has been met. In order to process and close the claim, AllRisk will furnish all documentation to support the insurance, accounting needs and if applicable, FEMA reimbursement needs of the client.

Approach for Fire, Smoke, Soot and Odor

Response procedures for Fire, Smoke, Soot and Odor almost always involve water (from sprinklers and fire department) and suppression systems.

The AllRisk Supervisor's response is similar framework to procedures for a water event, with the following key additions:

- Supervisor's inspection will include important determinations such as: presence of hazardous chemicals, does the building have electric / working alarms, HOW FAR does soot and odor reach BEYOND the source and obvious affected areas, was the ventilation system shut down and when, is the building accessible or is the FD still engaged in cause & origin, when will the source room be released, etc.
- Address problem solving and design for containment and negative pressure. When buildings are loaded floor to ceiling with contents, in some scenarios more elaborate (and multiple chambers) need to be constructed so to ensure that cross-contamination does not occur in the manipulation and cleaning of contents.
- Address ventilation system inspection and cleaning.
- Deodorize / fog if necessary.
- Cleaning steps are best practice in accordance with IICRC standards inclusive of hepa vaccing of loose soot, soot removal with dry sponge, cleaning with appropriate detergent and rinsing with clean water.
- Address if contents will be deodorized in ozone chambers on site, or at AllRisk's location.
- Address if environmental consultant will be utilized for testing before, and after for post remediation verification.

Other Resources - Full Service General Contractor: As a licensed general contractor in the State of NJ, AllRisk has the ability to provide full-service reconstruction, thus minimizing downtime and costly business interruption.

Other Resources - Educational Programs, Preventive Actions, and CEU's: With an emphasis on preventive and preparedness best practices, AllRisk is consistently tapped as an educational resource and speaker. When our region was faced with what one insurance broker called "a tsunami of mold claims", it was AllRisk who initiated the development of "Proactive Mold Management for Schools", a program approved for CEU's and delivered to audiences of New Jersey's largest educational professional development group (NJASBO), and largest school joint insurance funds (ERIC North of NJSBAIG and the SPELL JIF). Prior to this program, there was no heightened awareness or empowerment for school administrators to understand the impact of record setting weather, the role of relative humidity in their facilities, how to monitor humidity levels in their facility, and how to adjust their maintenance staff's water-generating activities and procedures *to prevent mold producing conditions*. AllRisk consistently collaborates with public entity professionals to deliver best practices in the ongoing cycle of updated emergency operations planning by sharing case history lessons learned.

By video conferencing between AllRisk supervisor on site of affected insured, AllRisk Management at the home office command center, and the client contact off site, AllRisk served as the "eyes and ears" for our clients, and shared what we observed in real time (or on video) as the client was prohibited from gaining access in person. Likewise, live stream applications were a well leveraged tool of the AllRisk contract management plan to share critical information during fast paced, high volume periods of major events).
- AllRisk utilizes PSA project and construction management software, Access software, Office suite, and insurance based estimating software inclusive of Xactimate and Integra claim.
- AllRisk utilizes a secure internal network for the storage and usage of all documentation. This equipment is maintained by an employed consultant. All information is protected and backed up daily.
